WHEREAS, the Texas Forest Service has determined that drought conditions exist in Coke County; and

WHEREAS, on the 23rd day of May, 2011, the Commissioners Court of Coke County has determined that the normal danger of fire in the unincorporated areas of Coke County is greatly enhanced by the extremely dry conditions now existing; NOW, THEREFORE, the

A. No person may sell, detonate, ignite, or in any way use fireworks classified under 49 C.F.R. part. 173.100(r)(2) (10-1-86 edition), as "skyrockets with sticks" and "missiles with fins" in any portion of the unincorporated area of Coke County.

B. This Order does not prohibit:

1. common fireworks, small in size classified as Class C explosives;

2. large fireworks devices designed primarily to produce visible or audible effects by combustion, deflagration, or detonation and classified as Class B explosive by the U.A. Dept. of Trans. (TEX.OCC.CODE, Chapter 2154).

C. A person commits an offense if the person knowingly or intentionally violates a prohibition established by this Order. An offense under this order is a Class C. Misdemeanor.
