**PUBLIC INPUT SOUGHT FOR PROPOSED REHABILITATION OF FLOODWATER RETARDING STRUCTURES NOS. 4 AND 5 OF THE KICKAPOO CREEK WATERSHED, COKE COUNTY, TEXAS**

The Coke County Soil and Water Conservation District (SWCD), Coke County Kickapoo Water Control and Improvement District No. 1 (WCID), Texas State Soil and Water Conservation Board (TSSWCB), the United States Department of Agriculture-



Natural Resources Conservation Service (USDA-NRCS), Coke County, and the City of Bronte are holding a public scoping meeting as they begin the planning process to develop a Supplemental Watershed Plan and Environmental Assessment (EA) for Floodwater Retarding Structures 4 and 5, which are located approximately 8 and 5 miles north of Bronte, Texas, respectively.

The project is a part of the Small Watershed Rehabilitation Amendments of 2000 (Section 313, PL 106-472). This legislation authorized the USDA-NRCS to work with local community leaders and watershed sponsors to evaluate and potentially rehabilitate aging watershed dams built under Public Law 78-534, Public Law 83-566, and the Pilot Watershed programs.
