# INSTRUCTIONS TO BIDDERS BID INFORMATION THE BID

Competitive formal bids will be received for: Generator Purchase & Installation.

Coke County is seeking bids for the purchase and installation of 2 propane generators. Generators will have a minimum rating of 25 kilowatts, an automatic transfer switch with mobile link connectivity, plus a minimum five year warranty (provided by the manufacturer). One generator will be installed at the Robert Lee Rec Hall, at 150 County Park Road, Robert Lee, TX; and the other will be installed at the Bronte Rec Hall, 350 E. Park Rd., Bronte, TX. Generators will be installed on a concrete pad constructed by bidder, located a minimum distance from each building, according to code. Bidder will also be responsible for ditching for underground wiring and propane connection from Rec Hall to each generator and propane tank. Bidder will



provide and install wiring, conduit & fittings, and hardwire each generator to existing electrical system. Bidder will also supply and install connections from each generator to propane tank. Coke County will supply one five hundred gallon propane tank and propane to each location.
