At the public hearing, the County will receive information to determine, among other things, whether the: improvements sought within the proposed zone are feasible and practical and would be a benefit to the land to be included in the zone and to the County after the expiration of any tax abatement agreement; proposed zone designation would contribute to retention or expansion of primary employment or would attract major investment in the zone that would be a benefit to the property to be included in the zone and would contribute to the economic development of Sterling County, Texas and (3) proposed zone is eligible for commercial-industrial abatement.

The land area being considered for the designation is located wholly in Sterling County, Texas, contains approximately 9,331.90 contiguous acres, more or less, is located on and near the boundary of Glasscock County, Texas with Sterling County, Texas, south of Texas Highway 158, and is composed of certain tracts or parcels of land in the following abstracts of Sterling County, Texas, more particularly described in the public records of the Offices of the County Clerk of Sterling County, Texas and the Sterling County Appraisal District, to which reference is made for all purposes: Sterling County Abstract Nos. 1262, 1251, 568, 1139, 1063, 1097, 1064, 570, 553, 1061, 1066, 1052, 565, 52, 1197, 808, and 973.

It's what led them into a legal dispute through the 1980s.

El Paso resides atop the Hueco Bolson aquifer, which extends into Mexico and a little into New Mexico. Meanwhile, El Paso's neighbor, southern New Mexico, is atop the Mesilla Bolson aquifer, which extends into Mexico and a little into Texas. When El Paso officials saw their aquifer's water level decrease, they argued that southern New Mexico had more underground water than they needed and applied to drill water wells on their neighbor's

land. New Mexico rejected those applications.

New Mexico officials said allowing El Paso to buy their public water violated their state constitution. It was like giving away state property. But because it was cheaper to challenge New Mexico's laws in court than to get water from anywhere else, El Paso sued. And because of the animosity between the neighbors, it became one of the country's bitterest water conflicts.

Before long, New Mexico's then Lt. Gov. Mike Runnels urged his constituents to refrain from spending their dollars in El Paso. At least one millionaire from New Mexico, Bill Stahmann, closed his corporate account with El Paso's State National Bank and resigned as its director. Stahmann told El Paso if their city didn't have enough water, they should limit their growth. Even the Las Cruces Women's Council of Realtors got involved. They distributed bumper stickers around southern New Mexico that read, "Thou shall not covet thy neighbor's water." The 11year dispute ended with a "settlement agreement," and El Paso didn't get any water.
