WHEREAS, the City of Robert Lee, Texas, previously created a Type A Economic Development Corporation under Chapter 504 Texas Local Government Code known as the City of Lee Economic Development Corporation and hereinafter referred to as the "Robert Lee 4A EDC"; and

WHEREAS, the City of Robert Lee, Texas, has further created a Type B Community Development Corporation under Chapter 505 Texas Local Government Code known as the Robert Lee Community Development Corporation and hereinafter referred to as the "Robert Lee 4B CDC"; and

WHEREAS, the City of Robert Lee has a population of less than 7,500; and

WHEREAS, pursuant to House Bill 3302, the Texas Legislature has added new Section 504.171 of the Local Government Code authorizing a city as defined, to permit by ordinance Type a Corporation such as the Robert Lee 4A EDC to undertake projects of a Type Corporation such as the Robert Lee 4B EDC authorized under Chapter 505; and
