A tax rate of \$0.640837 per \$100 valuation has been proposed by the governing body of COKE COUNTY.

EFFECTIVE TAX RATE	\$0.640837 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for COKE COUNTY from the same properties in both the 2014 tax year and the 2015 tax year.
