 AN ORDINANCE OF
 THE CITY OF BRONTE,
 TEXAS AMENDING
 ORDINANCE NO. 177
 AND ORDINANCE NO.
 14-04; DESIGNATING
 ADDITIONAL
 INTERSECTIONS AS
 STOP OR YIELD
 INTERSECTIONS;
 PROVIDING A REPEALER
 CLAUSE; PROVIDING A
 SAVINGS CLAUSE; AND
 PROVIDING AN
 EFFECTIVE DATE.**

WHEREAS, the City of Bronte, Texas is a Type A general-law municipality located in Coke County, created in accordance with the provision of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS Chapter 544.003 of the Texas Transportation Code authorizes a municipality to designate intersections as stop or yield intersections and place signs at the entrances to said intersections.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Bronte, Texas that:

SECTION 1 - AMENDMENT OF SCHEDULE I. Section 8, Schedule I of Ordinance 177 is amended by adding thereto the following intersections:

SECTION 3 - REPEALER
 All other ordinances and ordinance provisions in conflict with the provisions of this Ordinance shall be, and the same are, hereby repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SECTION 4 - SEVERABILITY If any section, paragraph, or provision of this Ordinance shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of the Ordinance as a whole or any part of provision thereof, other than the part so deemed to be invalid or unconstitutional.

SECTION 5 - EFFECTIVE DATE This ordinance shall become effective upon adoption by the City Council and after publication as required by the Texas Local Government Code.
