Important Special Meeting! The Coke County Commissioners' Court accepted a sales contract from International LPS, LLC or its assignee for the Coke County Juvenile Detention Center during a special meeting held Tuesday morning, August 6, 2019, at the Courthouse in Robert Lee. Important points of the contract include a sales price of \$550,000.00; earnest money in the amount of \$5,000.00; purchase of a 90 day termination option period for \$2,500.00 of the earnest money; a contingency voiding the contract if potential grants are not awarded; and a closing date of January 15, 2020, with the ability to extend the date pending award date of grants. International LPS, LLC is headquartered in McAllen, Texas, and the contract was signed by Luis Cantu, representing the company. Although the company's intentions for the property were not discussed during the meeting, Commissioner Williams noted that the employment opportunities coming with this project would be significantly beneficial to Bronte and Coke County. When questioned by Commissioners, Paul Gohman, Mayor of Bronte, assured Commissioners water and sewer utility services would be made available to the property. Commissioner Williams made a motion to authorize Judge Spain to sign the contract for Coke County. The motion was seconded by Commissioner Sefcik and approved unanimously. Attending the special meeting were Judge Hal Spain and Commissioners Paul Williams, Joe Sefcik, Donnie Robertson and Marshall Millican. Also present were County Clerk Monica Reyes, Sheriff Wayne McCutchen, Bronte Mayor Paul Gohman, Bronte City Secretary Teresa Ballard, Treasurer Therese Emert, Auditor Vallery Johnson, and Judge's Executive Assistant Lorrie Martin.
