PUBLIC HEARING CITY OF BRONTE NOTICE OF 2017 TAX YEAR PROPOSED PROPERTY TAX RATE

A tax rate of \$0.431301 per \$100 valuation has been proposed for adoption by the governing body of the City of Bronte. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearing be held by the governing body before adopting the proposed tax rate.

The governing body of the City of Bronte proposes to use revenue attributable to the tax rate increase for the purpose of meeting the Fiscal Year 2018 budget.

PROPOSED TAX RATE	\$0.431301 per \$100
PRECEDING YEAR’S TAX RATE	\$0.420109 per \$100
EFFECTIVE TAX RATE	\$0.404029 per \$100
ROLLBACK TAX RATE	\$0.436351 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for the City of Bronte from the same properties in both the 2016 tax year and the 2017 tax year. The rollback tax rate is the highest tax rate that City of Bronte may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

Property tax amount = (rate) x (taxable value of your property)/100
