Materials will be exchanged Monday and Tuesday and elementary awards will also be given to the students during this time.

Mr. Kuhlmann is in the process of trying to set up a graduation ceremony for the seniors. It is currently scheduled for Friday, May 15, at 6 pm at the football field. TEA guidelines will have to be followed. The students will be presented their diplomas by their parent or escort. Mr. Cooper will be speaking, as well as the Valedictorian and Salutatorian. If weather is an issue, graduation will take place the following Friday.

Superintendent's Report

Mr. Siler advised health screenings were passed out to those attending graduation and staff will be wearing masks. There will be five attendees allowed in the stands and five in cars in the parking lot. The ceremony will also be livestreamed on Facebook. If neither dates work for graduation, there will have to be a virtual graduation before June 1.

The June regular board meeting will need to be held prior to June 15 to take action on security training.

Mr. Siler presented the finances of the district to the board. He advised estimating expenses is difficult. He also found out last week that FED program money can be rolled

over to next year. BISD is currently estimating looking at ending the year with a positive \$250,000. The transportation allotment will possibly be reduced as busses are not currently running. The Lonestar Investment Pool interested earned has drastically decreased since COVID-19 and that is a concern, as well as everything about next year's budget being up in the air.

There was no legislative update.

The board entered into executive (closed) session at 7:35 pm and came out at 7:55 p.m.

Bronte ISD has a \$25,000 grant to be spent on safety and security. Mr. Siler has been in contact with security companies to get quotes for new security cameras. Mr. Siler recommended no action be taken until updated bids from VGI, Entertel, and Unify are received.

Mr. Siler recommended a one-year probationary contract to Kaci Follis. David McWright made a motion to approve this recommendation. Jodie Arrott seconded. Ayes: 7, Nays: 0. The motion passed.

There were no 2019-2020 budget amendments.

The regular June meeting will take place June 11, 2020, at 7 pm.

Josh Schoenfield made a motion to adjourn the meeting and Terry Queen seconded. The meeting adjourned at 8:20 p.m. Ayes: 7, Nays: 0, Motion passed.
