### NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.301163 per \$100 valuation has been proposed by the governing body of EAST COKE COUNTY HOSPITAL DISTRICT.

PROPOSED TAX RATE \$0.301163 per \$100 NO-NEW-REVENUE TAX RATE \$0.290582 per \$100 VOTER-APPROVAL TAX RATE \$0.301165 per \$100

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for EAST COKE COUNTY HOSPITAL DISTRICT from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that EAST COKE COUNTY HOSPITAL DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that EAST COKE COUNTY HOSPITAL DISTRICT is proposing to increase property taxes for the 2021 year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 27, 2021, AT 5 PM at BRONTE HEALTH AND REHAB CENTER, 900 S. STATE STREET, BRONTE, TEXAS.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, EAST COKE COUNTY HOSPITAL DISTRICT is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the EAST COKE COUNTY HOSPITAL DISTRICT at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homesteaded by EAST COKE COUNTY HOSPITAL DISTRICT last year to the taxes proposed to be imposed on the average residence homestead by EAST COKE COUNTY HOSPITAL DISTRICT this year.
