ORDINANCE 14-08  
REPLACING  
ORDINANCE 14-01  
THE STATE OF TEXAS  
COUNTY OF COKE  
CITY OF BRONTE

WHEREAS, the City of Bronte is subject to certain federal and state environmental laws, rules, and regulations, governing the collection and disposal of garbage and trash, as herein defined; and

WHEREAS, it is the intent of the City to comply with all such environmental laws, rules and regulations for the benefit, welfare, and best interest of the citizens of Bronte;

THEREFORE, BE IT ORDAINED AS FOLLOWS:

The City of Bronte shall furnish garbage collection service pursuant to the understated rules, regulations, and stipulations as specified in this ordinance and as may be amended, to-wit:

A. DEFINITIONS: T h e following terms shall be defined for the purpose of this ordinance as follows, to-wit:

1. Garbage – All glass, tin cans, paper boxes, waste materials from kitchens, refuse from kitchens, residential waste materials, grocery store waste material, restaurants, cafes, hotels and such other waste and/discarded material as may be discarded from residential and/or commercial locations in and about the City of Bronte.

2. Trash – Rubbish, including but not limited to yard cleanings, grass clippings, leaves, and other such discarded residential and/or commercial material as may be discarded by residential and/or commercial material as may be discarded by residential occupants and commercial businesses in the City of Bronte.

B. C O N T A I N E R S REQUIRED:

1. Each and every owner, occupant, tenant and/or lessee using or occupying any building, house or structure within the City for residential usage, church utilization, schools, lodges, commercial establishments, businesses, and/or o t h e r purposes not receiving sanitation container system service as described herein, shall be provided a 96 gallon polycart.

C. DESIGNATED PICKUP POINT FOR CONTAINERS FOR REMOVAL:

As to all house, buildings and premises from which garbage is to be collected and removed which are adjacent and adjoin to a street, the owner, occupant,

tenant, and/or lessee of the premises, shall be required to place the polycart(s) at the curb adjacent to the City street fronting the premises in or that it may be easily accessible to the City's collection service in its collection and removal of garbage. In the event it is not practical to collect the garbage from a street as to those locations and/or sites where said street is not fully “developed,” “opened””, or other obstruction may exist, the owner, occupant, tenant, or lessee of the premises shall place polycarts at points designated by an authorized agent of the City, said point being accessible to the City Agent.

The designation of the location of polycarts as designated herein shall be at the sole and complete discretion of the City in regard to the most accessible point for collection and removal of the same. The decision of the City in regard to the location of the designated point shall be final.

D. WET GARBAGE: All garbage and trash that is mixed with water and/or other liquids shall be drained before being deposited in the polycart or receptacle.

E. A U T H O R I Z E D PERSONS TO COLLECT AND HAUL GARBAGE AND TRASH:

The City of Bronte, by and through is dully authorized agents, licensees, permittees, franchises, and employees shall be the only authorized person to empty polycarts and/or containers and convey, haul and transport the same through the streets and public roads of the City of Bronte. The collection charges for garbage service shall be made to all residents using water within the City of Bronte, regardless of whether or not the residents have polycarts for collection. The fee for garbage hauling shall be considered a part of the city services, unitized as to the water and septic sewer service.

F. C O L L E C T I O N CHARGES:

Failure to pay the garbage collection fees shall be sufficient grounds for the discontinuance of all city utility services, including but not limited to, water and sewer service.

No garbage collection service will be offered unless the city lot or location is the recipient of city water services.

The monthly rates and charges shall be, to-wit:

(a) Premises used for private residences, single or double unit apartment houses, single mobile home sites and/or locations, shall be charged \$17.50 per family unit as to occupied

residences, apartments, and units. One polycart container will be provided for each trash service location. The charge for extra polycarts shall be \$ 10.50 per polycart.

(b) Premises used for commercial business, and/or public purposes not received sanitation container service as described herein shall be charged \$25.00 per month. One polycart container will be provided for each trash location. The charge for extra polycarts shall be \$10.50 per polycart.

(c) Premises located outside the City Limits shall be charged at a rate of 1.5 times above the rate charged the City by its trash collection provider. Said premises must be served by another City utility for which a bill is sent.

(d) If a polycart is lost or damaged by the resident, a \$60.00 replacement fee will be assessed.
