Discussion with the City Attorney regarding the Supreme Court ruling was tabled as the City Attorney was not present.

The garbage collection franchise fees discussion was tabled as the City Attorney was not present.

Discussion was held regarding the RV Ordinance and the Williams RV Park. An agreement was made in 2017 with B&W RV Park to put up a fence as required by the RV Ordinance. The fence was not put up and a warning was sent to the address according to CAD. The previous owner came to address the violation and to inform the council that he is no longer the owner and the RV Park is no longer open.

A motion was made by Mike Stephens to appoint Tracy Grantham to the Economic Development Corporation 4A Board. He was seconded by Jonathan Torres and the motion carried with a vote of 3 - 0.

A motion was made by Jonathan Torres to approve of the Engagement Letter with Merritt, McLane, and Hamby for the 2021-2022 Audit. He was seconded by Mike Stephens and the motion carried with a vote of 3 - 0.

Animal Control Officers presented a PowerPoint regarding the City potentially starting a euthanasia program. A motion was made by Jonathan Torres to allow the Animal Control Department to start the process by submitting the application for the Drug Enforcement Administration license for animal euthanasia. He was seconded by Mike Stephens and the motion carried with a vote of 3 - 0.

A property owner wished to

donate a property to the City but the City does not have a policy regarding donated properties. The City Attorney drafted up a policy for the Council and donated properties would have to be presented and approved by the Council. Jonathan Torres made a motion to adopt the Donation of Real Property Policy and changing City Administrator to City Secretary. He was seconded by Tracy Grantham and the motion carried with a vote of 3 - 0.

## Secretary's Report

Bees have been removed from a vacant house after reports of attacks on a neighboring house. There have been 24 property abatements sent out to property owners and six of which were granted extensions. The annual TML Conference is approaching if any Council Members would like to attend. TML IRP rates for 22-23 and Worker's Comp have increased due to inflation.

## Superintendent's Report

There were 47 work orders, 3 minor water leaks, 0 sewer stop, and one sewer tap replaced. There was one major electrical failure resulting in a system wide shut down and a water boil notice was implemented until that following Tuesday. They are looking into a battery backup for controls and working with AEP to replace the fried connections. There was one illegal dumping reported in the Post Office Cardboard Recycling bin and it was reported to the police.

A motion was made by Tracy Grantham to adjourn the

regular meeting at 8:07 pm and she was seconded by Jonathan Torres. The motion carried with a vote of 3 - 0.

## August 10, 2022

The Robert Lee City Council met in special session on Wednesday, August 10, 2022, at 6:30 pm at City Hall.

Those present included Mayor Jason Moran; and Council Members Jonathan Torres, Tracy Grantham, Mike Stephens, and Josh Tennison.

Call to order was held, a quorum was determined, and the meeting was declared open at 6:39 pm.

A motion was made by Tracy Grantham to appoint Josie Dean as the City of Robert Lee Tax Assessor for the year of 2023. She was seconded by Jonathan Torres and the motion carried with a vote of 3 - 0.

The Emergency Preparedness Plan was tabled until the regular meeting.

RA Bagwell is wanting to move their above ground petroleum tanks inside the City limits. The Council will not implement any further restrictions and allow TCEQ to solely regulate this business. The item will be revisited when more information is gathered from RA Bagwell.

The Emergency Preparedness Plan and Street Affair Contribution was requested to be added to a future agenda.

A motion was made by Tracy Grantham to adjourn the meeting at 7:22 pm and was seconded by Josh Tennison. The motion carried with a vote of 3 - 0.

Tracy Grantham made a motion to appoint Mike Stephens to the vacant position on the Council and was seconded by Jonathan Torres. The motion carried with a vote of 3 - 0.

A motion was made by Jonathan Torres to accept the resignation of Council Member David Lewis. He was seconded by Tracy Grantham and the motion carried with a vote of 3 - 0.

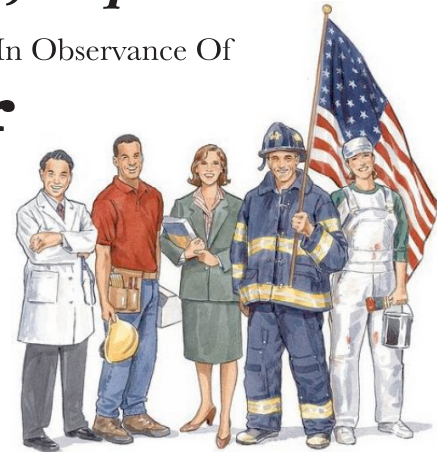
