THE CITY COUNCIL OF THE CITY OF ROBERT LEE DOES HEREBY AMEND SECTION G AND SECTION I ESTABLISHING NEW RATES FOR TRASH COLLECTION SERVICES. SECTION G: COLLECTION CHARGES

The following rate schedule is hereby implemented as stated in Exhibit A of the Solid Waste Contract between the City of Robert Lee and Duncan Disposal:

(a) Premises inside city limits used for private residences, single mobile home sites and/or locations, shall be charged a base rate of \$17.15 per month per

(e) Base rate may be adjusted monthly based on the previous month's cost of diesel fuel as published by the Department of Energy - Gulf Coast Region.
