Dr. Gary Vannoy, D.V.M., from Ozona, will cover livestock diseases common to the area; Dr. Rick Machen, AgriLife Research and Extension livestock specialist, will provide vaccinating schedules and results; Dr. Cody Scott, with Angelo State University will cover range animal nutrition and protein/mineral supplementation; and representatives from Boehringer-Ingelheim and Texas Vet Lab, Inc. will be covering pharmaceutical improvements and available

products.

During the event Stay Tuff Fencing, Yellowhouse Machinery Company and Priefert Ranch Equipment will offer on-site live demonstrations of new innovations to the livestock and equipment industry.

Corey Owens, instructor/research associate with the ASU Department of Agriculture will have graduate students on hand to display their rangeland research projects. Both students and speakers will be available to answer questions about their respective research projects and presentations.

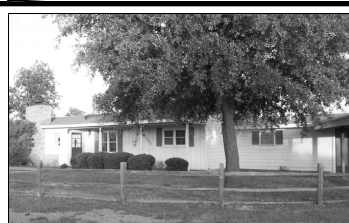
