(Continued from page 5) As part of the Texas College Preparation Program, Texas juniors may ask for a free ACT exam voucher from their counselors. Those who cannot take the April test may receive a voucher for the June 11, 2011 test.

The ACT is a curriculumbased achievement exam. It tests what students have actually learned in school, not their aptitude for learning. The ACT also measures what students need to know to be ready for first year credit-bearing college courses based on ACT Readiness College StandardsTM. Every student's results can be tied directly to these consistent standards.

The ACT has sections—English,

mathematics, reading and science—and takes about three hours to complete. Students who take the ACT Plus Writing complete an optional writing test that requires an additional 30 minutes. Unlike other exams, students are not penalized for guessing or answering all the questions on each test section. In fact, it is beneficial for test takers to answer all questions within the time allowed.

During registration, students may select up to four universities to receive their score reports. ACT scores are accepted by all four-year colleges and universities across the United States. ACT reports scores only when requested to do so by the student. Additional score reports are available for a small fee.

All students complete a detailed inventory of questions during ACT registration. Each test taker receives an ACT score report that includes a wide variety of information to assist with high school course selection, college readiness, career planning, and college admissions.

The cost for the ACT test without writing is \$33. When combined with the optional ACT Writing Test, the total cost is \$48. Students who qualify may apply for a fee waiver through their high school counselor.

However, t h e best preparation is to take rigorous core courses in school, study hard, and learn the academic skills needed in college.

Direct & Countercyclical Payment Signup Ends June 1

USDA Farm Service Agency reminds producers that the deadline to sign up for the 2011 Direct and Counter-cyclical Payment (DCP) program is June 1,

Payments are calculated using base acres and payment yields established for each farm. Eligible producers receive direct payments at rates established by statute regardless of market prices. Advance payments of 22 pergram will be available starting December 1, 2010. The remaining 78 percent of the DCP payment will be issued

after October 1, 2011. Counter-cyclical payments vary depending on market prices, and are issued only when the effective price for a commodity is below its target price (which takes into account the direct payment rate, market price and loan rate).

"It is important that producers submit their DCP contracts before June 1, 2011 because applications will not be approved after this date.

Producers can fill out a DCP contract at any USDA Service Center or online. To access the online service, producers must have an
